**ORDER:**

In the reference first read above, Government of India have issued guidelines for revision of food norms, cooking cost & honorarium to cook cum helper under National Programme for Mid Day Meal in Schools. As per the guidelines of Government of India, the cooking cost has to be revised by 7.5% on 1.4.2010 and again on 1.4.2011. Accordingly, the cooking cost had been revised by 7.5% with effect from 01.04.2010 to Primary Schools and to Upper Primary School, vide reference second read above.

2. In the reference third read above, the Commissioner & Director of School Education, Andhra Pradesh, Hyderabad has submitted proposal to the Government for issue of executive orders for implementing the Central share for revised Cooking cost under Mid Day Meal Scheme in Primary and Upper Primary Schools with effect from 01.04.2011, as per the norms of Government of India.

3. Government after careful examination of the matter, hereby order for implementing the Central share for revised Cooking cost under Mid Day Meal Scheme in Primary and Upper Primary Schools as indicated below with effect from 01.04.2011.
